The final closing of Capital Dynamics' US Solar Energy Fund ends a successful fundraising with a total of USD 282 million in committed capital from over 15 global institutional clients from the US, UK, Australia, Germany, Korea and Japan; plus high net worth individuals and family offices.

The Fund is focused primarily on commercial-scale solar photovoltaic projects located in multiple US states featuring a diverse range of both ground-mounted and rooftop installations. The Fund has committed capital to over 50 projects in varying stages of completion in Massachusetts, New Jersey, Pennsylvania and California, including one of the largest ground-mounted solar energy projects constructed in New England to date and one of the largest US rooftop projects in New Jersey. The Fund's project investments are typically supported by power purchase agreements with a duration of 20 years or more with investment-grade utilities and corporations, translating into long-term, visible cash flows for investors.

"We are delighted with the success of our first solar energy fund and the quality of investor interest we were able to generate," said David Scaysbrook, Managing Director and Head of Clean Energy and Infrastructure (CEI) at Capital Dynamics.
